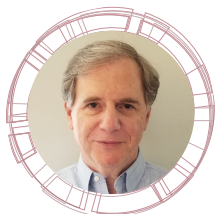

ELIGIBILITY

All programs require participants to be at least 18 years old and have finished at least one year of full-time study with an undergraduate institution prior to the start of the program.

Most programs are appropriate for all academic or professional backgrounds and do not have required prerequisites. All programs are taught in English.

All participants are expected to have a stable internet connection and computer access to complete the virtual program.

REQUIRED APPLICATION MATERIALS

- Online application
- Résumé
- Motivation statement or short essays
- Academic transcripts (unofficial reports accepted)
- English language requirement (TOEFL, IELTS, or UChicago internal AEPA) for some applicants
