#### **Course Description:**

This course will provide an understanding of the application of health policy and analysis through the lenses of the Medicaid program. The course will begin with an overview of health policy and public health policy analysis and evaluation as it relates to the administration of the Medicaid program, a federal-state partnership and the largest health insurance program in the U.S., covering millions of low-income individuals and families. State Medicaid programs have been an important locus of innovation and improvement in health care delivery and financing as well as health outcomes. This course will also provide in-depth view of Medicaid policies from birth to the end of life, covering maternal and child health, mental health, long-term care, among other topics. This will include highlights of many state program approaches and innovations with designing their programs, applying the policies and evaluating the outcomes. This course is part of the Harris Health Policy Certificate program.

## **Learning Objectives:**

Upon completion of this course, the goal is for students to be able to:

- Understand the basic principles of the Medicaid program.
- Identify the main health policy issues related to Medicaid facing leaders today.
- Apply the core elements of policy option analysis to key issues in Medicaid.
- Write effective policy documents.
- Recognize the interconnections between Medicaid and public health issues.

#### **Course Requirements:**

Students are expected to attend and actively participate in all weekly sessions of the course. Prior to coming to class, students are expected to read the materials required for each session. Students are also strongly encouraged to read at least some of the supplemental readings, especially in areas of particular interest to them.

Each class will be centered on discussion and dialog. Students may be expected to have discussion questions prior to some of the sessions for guest speakers.

A Policy Brief, a Decision Memo and one Group Project will be required:

- The Policy Memo will be a short brief on state Medicaid programs' coverage (2-3 pages). Due Date: Week 4 (Jan. 31st)
- The Policy Brief will be an analysis on the topic related to the student's mock testimony. (5-7 pages) Due Date: End of Week 8 (Feb 24<sup>th</sup>)
- The Group Project will be a mock hearing. Students will work in groups to develop and then present a testimony statement (3 minutes each maximum) on one of four selected Medicaid policy issues discussed in class. Each group (the presentation panel) will have a witness from the perspective of one of the following stakeholders – government, providers (e.g., hospital association, physician association, etc.), and the consumers (e.g., consumer or community



organizations). There will be an Independent Committee member for each mock hearing. Each group will serve as the Committee members for another respective panel. **Presentations Week 9 (Feb. 28**<sup>th</sup>) *Note: Exam week is also reserved, if needed.* 

 Students are also encouraged to sign up to discuss an article in the news with the class to help contribute to our discussion as health policy issues are changing every day. Students should sign up for Google alerts for Medicaid related media to receive alerts.

For most weeks, the first half of the class will consist of a lecture and discussion on the selected topic. The second half of the class will be case study reviews with group breakout sessions or in-class activity as well as additional discussion.

Any student who believes they may need assistance should inform the Harris Dean of Students office by the end of the first week of class. The Dean of Students office will coordinate any student accommodations with Harris instructors.
