Course Description

This course will study the cultural, social, and institutional foundations of societies around the world, with a focus on fundamentals and mechanisms that are outside the scope of traditional models of economics and political science. Topics include forms of social organization, different p erceptions of reality (e.g., the spiritual and meta-human world), drivers of innovation and technology diffusion, motivations for participating in conflict, determinants of fertility and population growth, moral frameworks (including views about right/wrong, fairness, equality, ideology, and community membership), objectives and definitions of success, and societal equilibria. We will consider how these differences a ffect and are affected by cultural values, formal political and legal institutions, and economic development.

Typically, in economics and political science, the aim is to identify universal facts and relationships. The class will focus on differences and deviations from what we typically view as universals and on why social scientific research (ranging from economic theory to applied policy design) benefits from an understanding of the vast differences that exist around the world. As such, one of the class requirements will be an independent research project that asks students to take seriously the cultural differences that exist around the world and examine how, in one context, this is important for understanding economics or politics.

The course targets advanced Ph.D. students working in economic development, political economy, political science, cultural economics, or economic history.

Requirements

Enrolled students are required to complete the following assignments.

- 1. Reading summary for each class (25%): Before each lecture, students are required to write a short summary of one of the required readings. You are free to use whatever format you like for the summaries, but they should address the following: (i) Provide an overview of what you learned from the reading or, if you didn't learn anything, why you felt you didn't learn anything from it. (ii) Explain what you liked and did not like about the reading. (iii) Explain what you did not understand about the reading and/or describe any questions that came to your mind that the paper didn't address. Please email these to all faculty and TAs the day before lecture.
- 2. Class participation (25%): Students are expected to participate in class discussions. At a minimum, your goal should be to ask any questions that you raised in your reading summary during the class at the appropriate time. The rooms will be set up so that students can ask questions or make comments when the person lecturing is in another location. We strongly encourage and hope for substantial cross-location discussion.
- 3. Class presentation (25%): Each student will provide a short presentation on their research project on cultural differences. The presentation should be descriptive, with particular attention paid to the aspects of the society that are different from other societies discussed in class. The presentations will take place during a special class that is scheduled for Friday December 6th.
- 4. Four-page write-up (25%): Students are asked to write up the findings from the research they undertook for their presentation. The write up should incorporate the questions, comments, and feedback received during the presentation. These are due a few weeks after the final class.
